For SY2023-24, in addition to the AM/PM “Early Release” and AM/PM Regular Session options, students may also participate in a new pilot program **3rd Session (noted in yellow below)**. The CTE program tracks available in the SY23/24 pilot 3rd Session are: **Electrical, Graphic Design, IT Network & Security, and Mechatronics/Robotics**. When completing the PA-45A ISD Programs Days & Clock Hours form, please enter the correct total hours of CTC instruction and travel time. Travel time may only be claimed for full-time pupil school students, and the allowable travel time for the pilot 3rd Session is based on fewer days of travel needed. If your district has public school students attending multiple CTC sessions, please report each cohort on a separate tab in PA-45A.

FTE for Nonpublic & Homeschool Pupils

Nonpublic/Homeschool (NP/HS) pupils at CTC are claimed in membership only by the pupil’s resident district. Districts with NP/HS students will be notified by CTC staff via a nonpublic/homeschool pupil roster.

Travel Time

Full-time public students are the only students eligible for travel time. Allowable travel time is the reason program FTE listed is higher for full-time public school students than for part-time public or nonpublic/homeschool pupils.
